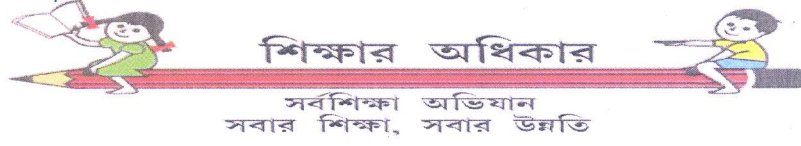

It is brought to the notice of all concerned that Formats of Unified District Information System for Education (U-DISE) 2017-18 and Student Database Management Information System (SDMIS) 2017-18 for all students up to class XII are being circulated to all Govt. / Govt. Aided / Govt. Sponsored / Private schools for filling up and submission.

For Vocational Education under CSS-VHSE Scheme of NSQF at Institutional Level at Secondary & Higher Secondary level are also being circulated to all Govt. / Govt. Aided / Govt. Sponsored.

As per Section 12 (3) of RTE Act, 2009, it is obligatory on the part of every school authority to provide information as sought by the concerned authority to enable the State to comply with the provisions of the Right of Children to Free and Compulsory Education Act, 2009.

It is the responsibility of the Head of the Institution to provide correct and full information in the DCF and to submit the same strictly within the time schedule. Submission of any incomplete and incorrect information may invite penal action against the person giving such information.
